

## **ASFALTART MARKET 2019 GUIDELINES**

The participation to the Asfaltart Market is subordinated to the subscription and to the unconditioned acceptance of the present guidelines.

The following categories are admitted to participate:

- 1) Artisans regularly registered at the chamber of commerce and at the craftsmanship register**
- 2) Subjects with a different fiscal placement**

who will be selected every year by a designated commission - part of the association that organizes the Asfaltart Festival - which will freely evaluate, and at its incontestable decision, the eligibility of each participation application form. Thus, it is absolutely essential a detailed specification, on the application form, with pictures attached, of all the products that will be exposed for sale.

The participation to previous editions does not represent any kind of right or guarantee of priority or precedence towards new potential participants.

The Commission is also free to decide the typology and the number of participants of each product category, possibly changing them from one edition to the following one.

The goods exposed for sale must be of exclusive creation, design and direct production of the underwriter of the application form.

Bought products, products that will be considered not appropriate to the spirit of the Asfaltart Market Festival, or products that could create any conflict with the local merchants will not be admitted.

The artistic craftsmanship Market is host inside the Asfaltart Festival because of the originality and the strong ethic content of all its products for sale, handmade and personally sold by those who produce them, just like all street artists who bring to the streets their exclusive artistic creations and expressions.

The minimum financial help required is 70 Euros for linear meter, with a maximum of 3x3 lm for gazebos and 4x2 lm for wooden desks. Only artisans with regular desks can occupy 4x2 lm.

The money deposited as a donation to the Kallmunz association ( a non-profit association), that organizes the Asfaltart Festival, goes entirely (100%) to contribute to the costs of the organization of the Festival itself.

When the Commission that examines the application forms and select the participants confirms (by email) the participation, a deposit of Euros 100,00 will have to be paid - through bank transfer - on the bank account written below. The final payment (=the missing amount of money) will have to be settled (also cash will be fine) before the end of the Festival.

To those who are part of category **Dot 1** a 20% discount on the total participation fee is agreed.

The Commission will not be considered responsible for the consequences originated from not respecting the rules regarding the fiscal placement and/or the obligations and the rules that regulate authorizations to sale on public land which from this could derive to exhibitors.

The subscription of the present guidelines commits the exhibitors to the unconditioned acceptance of what is in it included.

Not respecting the present guidelines will bring to the exclusion of the participation to future editions.

Assembly of market stands will have to be done and concluded before 11.00 am of the first day of Festival. Vehicles (of any kind) can entry the market area after 8.00 am, and will have to leave it before 10.00 am.
